FIRST AMENDMENT TO ORDINANCE 2017-1**

**FIRST AMENDMENT TO ORDINANCE DESIGNATING ALL-TERRAIN VEHICLE AND  
UTILITY-TERRAIN VEHICLE ROUTES AND REGULATING THE OPERATION OF ALL  
TERRAIN VEHICLES AND UTILITY TERRAIN VEHICLES IN THE TOWN OF LAFAYETTE,  
CHIPPEWA COUNTY, WISCONSIN**

**WHEREAS**, the Town enacted Ordinance 2017-01 (the “Ordinance”) on December 18, 2017 to designate ATV routes and regulate operation of ATVs and UTVs in the Town of Lafayette.

**WHEREAS**, the Town, after petition and public hearing pursuant to Section D of the Ordinance, tentatively approved changes to Section J of the Ordinance regarding ATV routes on March 19, 2018.

**NOW, THEREFORE**, as an amendment to the Ordinance, the Town Board enacts this First Amendment to the Ordinance (the “First Amendment”), as follows:

1. Section J of the Ordinance is deleted in its entirety and restated as follows:

**J. All-Terrain Vehicle Routes**

**1. Routes East of County Hwy K:**

- 75<sup>th</sup> Avenue from CTY HWY K to dead end
  - 203<sup>rd</sup> Street from CTY HWY K to intersection of 72<sup>nd</sup> Avenue
  - 72<sup>nd</sup> Ave to from intersection of CTY HWY K to intersection of 70<sup>th</sup> Avenue
  - 57<sup>th</sup> Avenue from intersection of 210<sup>th</sup> Street to dead end
  - 45<sup>th</sup> Avenue from intersection of 220<sup>th</sup> Street to dead end
  - 216<sup>th</sup> Street from intersection of 45<sup>th</sup> Avenue to dead end
  - 210<sup>th</sup> Avenue from intersection of 70<sup>th</sup> Avenue to intersection of 10<sup>th</sup> Avenue
  - 220<sup>th</sup> Avenue from CTY HWY X to intersection of 10<sup>th</sup> Avenue
  - 10<sup>th</sup> Avenue from CTY HWY K to intersection of 220<sup>th</sup> Street
  - 20<sup>th</sup> Avenue from CTY Hwy K to intersection of 220<sup>th</sup> Street
  - 30<sup>th</sup> Avenue from CTY HWY K to intersection of 220<sup>th</sup> Street
  - 40<sup>th</sup> Avenue from CTY HWY K to intersection of 220<sup>th</sup> Street
  - 50<sup>th</sup> Avenue from CTY HWY K to dead end

**2. Routes West of County Hwy K:**

- 197<sup>th</sup> Street from 5765 (Town Hall) to merger with 195<sup>th</sup> Street
- 195<sup>th</sup> Street from merger with 197<sup>th</sup> Street to intersection of 40<sup>th</sup> Avenue
- 50<sup>th</sup> Avenue from intersection of 195<sup>th</sup> Street to CTY HWY K
- 40<sup>th</sup> Avenue from intersection of 190<sup>th</sup> Street to CTY HWY K

**3. Routes on County Hwy K:**


- CTY HWY K from intersection of 72<sup>nd</sup> Avenue to the northern boundary of the Town of Lafayette located approximately at the midpoint of the Yellow River Bridge.


4. No person shall operate an all-terrain or utility terrain vehicle on any Town of Lafayette street or public property not designated as an all-terrain vehicle route or trail or in the manner provided in section J of this code.
5. The operation of all-terrain and utility terrain vehicles will not be permitted on state trunk highways except as may be necessary to cross the same and then in strict compliance with state law
6. Unless otherwise specifically provided, utility terrain vehicles shall be permitted to operate on the all-terrain vehicle routes in the same manner and subject to the same restrictions as all-terrain vehicles.
7. The routes and trails designated by this ordinance may from time to time be amended by action of the Lafayette Town Board after reviewing the recommendation of law enforcement regarding any such amendment. The Town Clerk shall promptly update this section upon publication of any ordinance changing the route designations provided for in this article and shall make copies of this section available to the public at the office of the Town Clerk.



All capitalized terms used in this First Amendment which are not otherwise defined herein shall have the meanings ascribed to such terms in the Ordinance.




